- **Stalking:** Persistent following, monitoring, or unwanted attention that causes fear, distress, or a feeling of being unsafe.
- **Digital and Online Harassment:** Harassment through computer systems, social media, or electronic means, including unsolicited explicit content, cyberstalking, or online behavior intended to harass or humiliate.

Legal Penalties: 1-5 Years Imprisonment

Additional Legal Updates

Beyond sexual harassment, the amendments also address the definition of "defilement" which was penetration involving genitals. The updated law now extends this definition to include the use of any body part or object for penetration, further closing loopholes and ensuring that a broader range of sexual assault acts are prosecutable.

This legislative milestone, driven by growing public awareness and advocacy for stronger protections against sexual misconduct, is expected to have a profound impact on societal norms and behaviors in Thailand.
